 I certify that my immediate family and guests have read the rules and regulations, and will abide by them at all times. We understand that a lifeguard may not be present at all times. People under the age of 18 must be accompanied by a parent or a responsible person that is 18 years of age or older and that **solo swimming is prohibited**. I also understand that violations of any rules and regulations could result in my loss of pool privileges. I also understand that I am responsible for all people using the key I will be issued, that all individuals entering the pool will follow the rules, that the key cannot be duplicated, and the door will be locked after entry/exit of the pool area. No-one is to be admitted without a key. I release and hold harmless the FHHPPOOL, the board members of the FHHPPOOL, and lifeguards from any responsibility and all injury that may be sustained by me, my family, or my guests while on FHHPPOOL property.

RULES AND REGULATIONS FOR THE FHHP POOL

1. Admission is limited to active FHHPPOOL members and their guests. Non-members are admitted to the pool only for private parties or as a guest of a member. Guests must pay \$1 per day (individual guest) or \$5 per day (family) fee. Members must sign the registration book and list all guests. Guest fees should be placed in the pouch attached to the registration book. Members may bring overnight guests free of charge if they live out of Clarke County. Guests are required to follow all rules and regulations. Members are responsible for their guests, and should accompany them for the entire stay. Do not leave without them.
2. Members will be responsible for any damage or theft caused by them or their guests.
3. Children 14 years and under must be accompanied by a parent or a responsible person 18 years or older. This rule will be strictly enforced for safety. Parents are expected to supervise their children while at the pool.
4. Absolutely NO unattended solo swimming at any time. Early morning and after 9 pm adult swimmers must have a buddy present. No one should enter the pool unless another adult is present inside the pool gates.
5. Small floats, inner tubes, and swimming aides are allowed only when they do not interfere with other members' enjoyment of the pool. No rafts. Hard balls, sponge balls, and other objectionable, small, or unsafe objects are not allowed in the pool. They can get trapped in the filters and lines, and damage the pool equipment. No furniture is allowed in the pool.
6. Horseplay is not permitted. This includes throwing people in the pool, holding under water, dunking, scuffling, striking, spitting or spouting of water, running and ball playing. No chewing gum in the pool.
7. All children using the baby pool must be toilet trained or wear swimming diapers. Only children 5 and under are allowed in the baby pool. PARENTS ARE RESPONSIBLE FOR CHILDREN IN THE BABY POOL. LIFEGUARDS ARE NOT RESPONSIBLE. We have very strict levels of water quality for the baby pool. Others are not to play, walk or put any inappropriate articles in the baby pool.
8. During an electrical storm, no one should be in or near the pool or under trees for **20 minutes** after thunder is heard or lightening is seen. (The Weather Service recommends an hour). If the storm continues the pool will be closed.
9. Glass is not permitted inside the gate area. Smoking is not permitted inside the fenced area. No alcoholic beverages allowed on pool property.
10. No food, drink, or wrappers allowed within 10 feet of the pool. Put trash in the trashcans and recycled items in the bins provided. Please clean up after yourself and your children.
11. Please return furniture to its proper place after use. Do not block steps or entrance areas with furniture.
12. Proper swim attire is required (no cut-offs, shorts, etc.).
13. Diving is not allowed in the shallow end.
14. Pets are not allowed inside the gate area or tethered on pool grounds.
15. FHHPool Inc, it's employees, officers and personnel have full authority to eject any person from the pool area for rule violation. Any member who witnesses rule violations should remind the person in violation of the policy. If the violator does not comply the incident should be reported to Bob Shields as soon as possible. Repeat violations may result in the loss of that person's pool privileges.

These Rules have been created in the best interests of safety and comfort, and in accordance with state of GA and Clarke county health regulations.
